II. APPROVAL OF MINUTES

1. 5012: City Council Special Meeting Minutes

There being no objections, corrections or changes to the minutes, Mayor Trainor declared the minutes approved.

2. 4994: City Council Meeting Minutes - August 2, 2021

The following changes will be made to the August 2, 2021, City Council Meeting minutes:

Packet page 8, Ward Reports, Ward #4 - Ms. Twyford: Insert a comma after the word "Ortegas" in the last bullet point to read "...specifically in the alley next to **Ortegas**, to the..."

Packet page 11, second paragraph: replace "...Mr. Hines, Ms. Philabaum..." with "...**Mr. Hynes**, Ms. Philabaum...".

Packet page 12, 4947: Amended Rules and Regulations of the Police Civil Service Commission: In the last paragraph remove the "s" on Towns to read "...with current **Charles Town** code.".

Ms. Natalie Green, on behalf of all the downtown businesses, spoke about the challenges the businesses are having with mentally ill people on the streets of Charles Town. Three main concerns are the safety of her customers, panhandling/loitering, and fecal matter being left on sidewalks and alleyways. She would like to have an open dialogue with the Council to come up with solutions to these issues.

1. 5010: City of Charles Town: County Seat

Mr. Mike Tolbert requested the Council petition the Jefferson County Commissioners to keep the county seat in Charles Town and to use the city block that the Jefferson County Court House is located on for their new government county complex.

2. 5011: National Association of Pet Pigs

Mr. and Mrs. Russell and Rebecca Lilly, who live in the Crosswinds community, reported that they were cited for breaking Ordinance 1102.07 Livestock, for their two pet mini pigs. Mr. Lilly reported that the United States Department of Agriculture (USDA) classifies mini pigs as companion animals not livestock. Crosswinds Home Owners Association has allowed the pigs in the development. Mr. Lilly asked the Council to allow for an exemption to the Ordinance for mini pigs.

2. 4980: Personnel Committee Report for August 9, 2021

Mr. George reported that the Personnel Committee discussed at their meeting the Police Department's grooming and appearance policy, the police staffing level analysis, the city's insurance coverage, the leave payout policy and the employment retirement benefit 457 program. The retirement program will be discussed later in the meeting.

3. 4981: Street Committee Report for August 12, 2021

Ms. Philabaum reported the following:

- The Street Committee has reviewed the Pavement Condition Assessment Report and will make a recommendation to the Finance Committee for a budget revision to proceed with repairs to the most impacted roads.
- A crosswalk has been created across E. Forrest Avenue at S. Church Street and minor work will need to be done to make it ADA compliant.
- Traffic data was collected on N. Mildred Street, E. Forrest Avenue, and E. Academy Street and showed that these streets rated as low priority for enforcement.
- A public meeting will be held at 2:00PM on August 30th with the property owners that will be impacted by the sidewalk project on S. George Street.
- City Staff is working on fixing the lights at the crosswalk on Augustine Avenue.

D. City Manager's Report

1. 4998: City Manager's Report for August 16, 2021

Mr. Hennessy reported the following:

- The Charles Town Car Show will be held on September 4, 2021, from 10:00AM-4:00PM.
- The Jefferson County Community Ministries (JCCM) will be hosting an open house on August 16th-18th from 9:00AM-12:00PM at their facility on 238 W. Washington Street.
- The Jefferson County Development Authority (JCDA) will conduct a zoom meeting with their Government and Legislative Affairs Committee on October 14, 2021, and is inviting local jurisdictions to participate.

• The skate park will be re-seeded in September.

1. 4988: Finance Committee - Revive Grant Program Funding

Mr. Hynes moved to approve the creation of the Revive Grant Program as proposed and allow capital funds from the Facade Improvement line item to be used to fund eligible projects. Mr. George seconded the motion.

Mr. Kratovil and Ms. Philabaum suggested increasing the amount of the Revive Program to \$40,000 per year.

Ms. Philabaum moved to amend the previous motion to also include referring the program back to the Finance Committee to increase it to \$40,000.00 per year. Mr. George seconded the motion, and it passed unanimously.
