Supporter Spotlight Series

Longtime Jefferson County property owner, Sarah Adams, has been an indispensable advocate in the fight against Rockwool since the very beginning. Her family's farm grows field crops and provides grazing for cattle. The farm now shares a border with the Rockwool facility. Sarah never imagined that this property, the former Jefferson Orchards, would become an industrial facility, noting that many other orchards in the area have been developed for housing. With her farm being directly under Rockwool's plume, her main concern is "being covered in toxic Rockwool's air pollution and having our drinking water polluted by Rockwool's inadequate and careless stormwater management." Her concern also extends to all surrounding agricultural and residential properties.

Sarah became involved with Jefferson County Vision after first learning about the proposed Rockwool facility through a request for a ROW for a new utility line. Sarah's farm has been listed on the National Register of Historic Places since 1975 and has also been included as a Jefferson County Historic Landmark. The Jefferson County Landmarks Commission received one of the earliest notifications from the state about the proposed industrial use of the former Jefferson Orchards. However, the Commission didn't even acknowledge the letter and failed to notify the owners of Hazelfield Farm and of local landmarks.

Sarah and her family have been invaluable supporters over the years, writing endless letters to public officials, submitting public comments, and attending 'Fridays for the Future' protests. They believe that Jefferson County is a unique place, home to many important resources and that the expansion of heavy industry in the county must be stopped. Sarah has also participated in anti-fracking efforts in New York. She hopes that we continue to ramp up our protesting efforts and involvement in the Danish media as well as make public the residents and businesses that are moving out of the county due to Rockwool.
